Supporting Social Chronic Clients In North Vancouver through Peer Mentorship

Background:

The North Vancouver RCMP are seeking to improve their stakeholder engagement strategies to address the issue of social chronic clients within their North Vancouver jurisdiction.

Relevance to City Goals:

This project relates directly to the City of Vancouver's priority of building a city for the people by aligning with the goal of developing and adopting a Community Well-Being Strategy.

Overview of the project:

Our recommendation is to develop a peer mentorship program to aid social chronic clients in identifying and navigating the appropriate programs available to them through the CMHA and ultimately find employment.

Project Details:

The completed program would be implemented in three stages:

1. Recruitment and training of the peer mentors.
2. Adapt CMHA's existing programs to meet the specific needs of social chronic clients.
3. Collaborate with local businesses to identify and create opportunities for employment for individuals with criminal records.

Key findings:

- A study in 2013 also concluded that peer support models along with support services resulted in an increase in the quality of life and decrease in involvement in the criminal justice system in people experiencing homelessness (Bean, Shafer, & Glennon, 2013).
- Research has proven that "shifting integrated mental health care to the community is unequivocally the most sensible economic decision, as community mental health services are up to five times less expensive than hospital-based care" (Malachowski, 2019).

Next steps / Future research:

The next steps for the RCMP and CMHA would be:

1. Develop a training program for newly hired peer mentors
2. Contact and recruit potential candidates for the peer mentor program
3. Work with the newly hired peer mentors to adapt the existing CMHA programs to attend to any specific needs of the social chronic clients that have not yet been addressed.

Breaking the offending cycle is a challenging experience so it is important that social chronic clients have a mentor that has been in their shoes to help them create connections.
